# Executive Summary

Boise State University invites applications and nominations for the position of Vice President of Finance and Chief Financial Officer (VP-CFO). As Idaho's largest state-supported University and a rapidly ascending research institution, Boise State is positioned for transformational growth.

Located in the scenic, vibrant capital city of Boise, Idaho, Boise State University is growing and progressing in many positive ways. Having recently achieved R2 classification with aspirations for R1 status, the University has expanded its research portfolio by 43% over the past five years.

Enrollment reached a record 28,500 students in fall 2025, reflecting its strong appeal in the dynamic capital city of Boise. Boise State is also ahead of schedule in its \$500 million **Unbridled fundraising campaign**, already securing more than \$477 million toward its 2028 goal. Nationally recognized for its Division I athletics, the Broncos will join the Pac-12 Conference in July 2026, further elevating the University's profile as a catalyst for innovation, economic development, and community impact.

Reporting directly to the President, the VP-CFO serves as a key member of the President's Executive Team and provides strategic financial leadership for all aspects of the University's fiscal operations. This leader also plays a key role in collaborating with external stakeholders through the Idaho State Board of Education, the Idaho Division of Financial Management, and the Legislative Finance Committee to advance Boise State's mission of student success, research excellence, and community engagement.

As the University's chief financial strategist and steward, the VP-CFO leads a comprehensive portfolio including **University Financial Services**, the **Office of Budget and Planning**, the **Office of Information Technology (OIT)** and the **Next Frontier program**, overseeing a team of 85+ professionals across the division. This role demands a collaborative leader who can navigate the complexities of public higher education finance while driving innovation and operational excellence in support of the University's ambitious **Blueprint for Success** strategic plan.

The successful candidate will demonstrate strong leadership, collaboration, and interpersonal skills, along with proven organizational, analytical, financial, and communication abilities. Candidates should be forward-thinking, enthusiastic, and entrepreneurial. A bachelor's degree in accounting, business, public administration, or a related field is required, along with at least five years of recent experience in public higher education or a related field. Preferred qualifications include a master's degree and 10 years of experience in fiscal management, with at least five years in an executive role, such as CFO, vice president, or associate vice president.

# POSITION OVERVIEW

The VP-CFO is a key member of the President's Executive Team and serves as a strategic partner to the Administrative Council, the Idaho State Board of Education, the Division of Financial Management, and the Legislative Finance Committee in advancing the University's fiscal goals. The VP-CFO safeguards the University's financial integrity, ensuring the effective planning and efficient use of resources in support of its mission and vision.

## The VP-CFO:

- Embodies principles of ethical and accountable leadership, strategic decision making, and collaboration with campus constituents to ensure the institution is positioned to meet the financial and operational goals of the Blueprint for Success.
- Blends financial acumen with strategic vision, stakeholder collaboration, and deep understanding of institutional mission and funding complexity.
- Models and inspires innovative thinking and a service mindset within the division and across the University.
- Partners with the University community to guide strategic investments, refine the budget model to advance research growth, align resources with strategic priorities, optimize state support, expand revenue opportunities, improve policies and systems for efficiency, and ensure student success remains central to all resource decisions.
- Plays a critical leadership role in analyzing and maximizing state support and other revenue-generating opportunities while informing decisions about tuition and fee rates and competing institutional needs.



- Works collaboratively with academic and institutional leadership to optimize the budget model as needed and ensure a streamlined, efficient, and effective budgeting and planning process that considers competing institutional priorities.
- Supports the Office of Continuous Improvement in managing IT change initiatives to streamline and enhance business operations.

### **Areas of Oversight**

- University Financial Services - Provides accounting services to the University community, including treasury, investments, controller, and more.
- Budget and Planning - Manages the overall University-wide budget through budgetary control practices. Co-leads the implementation of a responsibility-centered budget model.
- The Office of Information Technology – Provides several services through the following departments: Business Intelligence Reporting Services, Enterprise Technology and Operations, University Web Strategy, Technology Support and Engagement, including the Help Desk, OIT Communication, Information Security, Cloud and Archive Development, Learning Technology Solutions, OIT Business Services, Project Management of OIT projects, Research Computing, and the Testing Center.

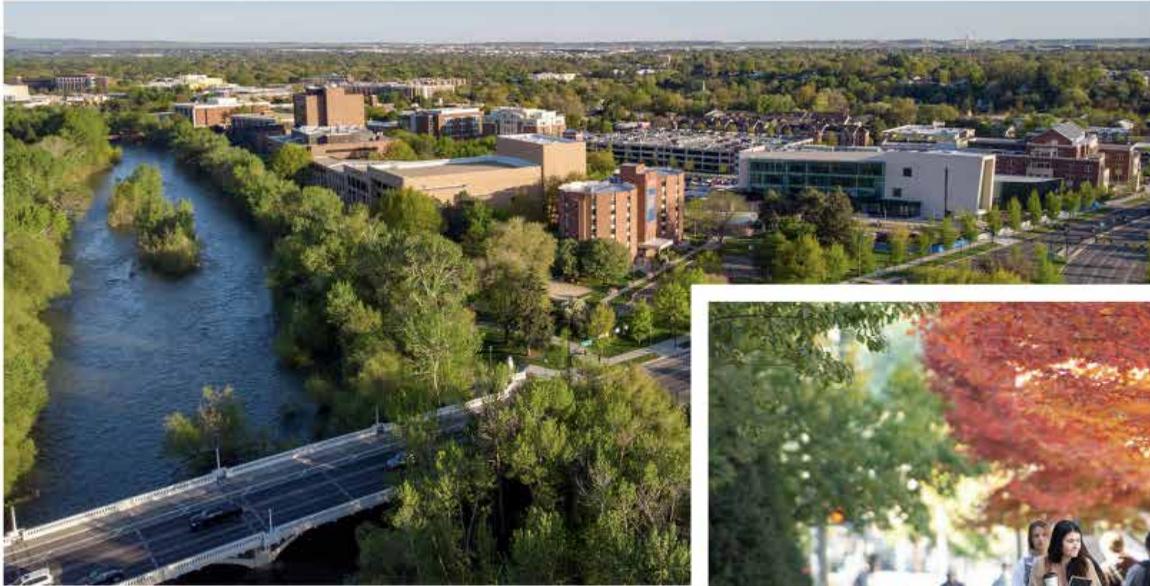

# OUR HISTORY

Boise State has marked many history-making moments since its beginnings as a junior college in 1932 to recent accomplishments as Idaho's largest university.

## Bronco Milestones



**1932:** Bishop Middleton Barnwell of the Episcopal Church oversaw the founding of Boise Junior College.

**1934:** The school became an independent junior college after the Episcopal Church ended its affiliation.

**1940:** The campus moved to its current location on the south bank of the Boise River.

**1965:** Boise Junior College gained four-year status as Boise College and began awarding baccalaureate degrees.

**1969:** The school joined the Idaho state system of higher education and got a new name: Boise State College.

**1974:** Boise State became a university, the third state university in Idaho. Buster Bronco, Boise State's beloved mascot, also debuted in 1974.

**1986:** Boise State changed its green field to blue.

**1989:** Boise State celebrated the largest enrollment in the state.

**1992:** The State Board of Education approved Boise State's first doctoral program in curriculum and instruction. The university now offers 15 doctoral programs, including educational technology, computer and materials science and biomedical engineering.

**2007:** The Broncos pulled off one of the greatest upsets in college football history by beating the University of Oklahoma in the 2007 Fiesta Bowl. This victory put Boise State University on the national stage and sparked rapid enrollment growth. Boise State surpassed 25,000 students in the next decade.

**2012:** Boise State opened the Micron College of Business and Economics Building in 2012. It was the first of several major campus expansion projects completed in partnership with Micron.

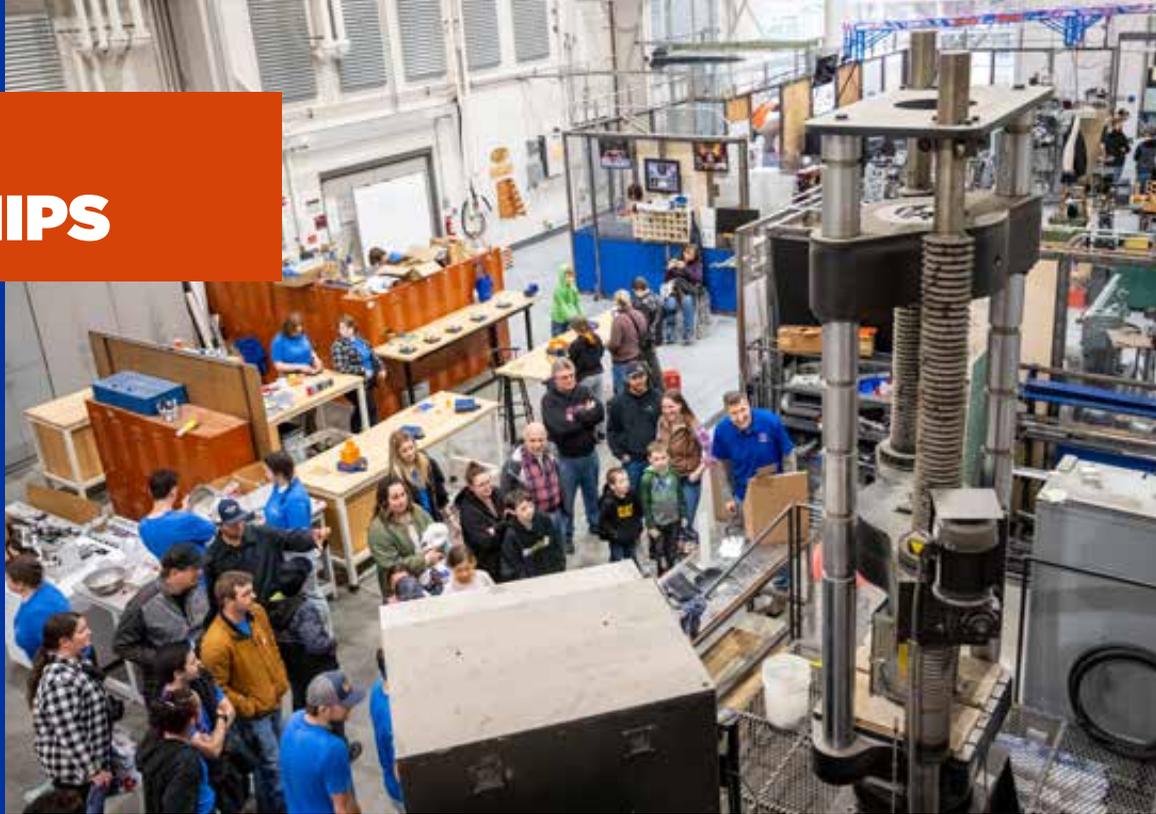

FACULTY HAVE AN ACTIVE PARTNERSHIP WITH A COMMUNITY ORGANIZATION

In 2006, Boise State was one of **only 76 universities** in the nation initially selected by the **Carnegie Foundation as a Community Engaged Institution.**

That classification was renewed in 2015 in recognition of the myriad ways that Boise State actively works to align with the cares, interests and activities of our local and state community.

This commitment to service continues to be a defining feature of the university. Boise State successfully renewed its classification as a Carnegie Community Engaged Institution, covering the period from 2024 to 2032.



Our university is leveraging existing partnerships and programs and developing new opportunities with Idaho employers and private partnerships. Together we are addressing workforce, research, educational and service needs.

Expanding partnerships across Idaho helps ensure rural communities have access to high-quality educational programming that fits their needs. Boise State recently created two new positions — a Director for University Industry collaborations and the President’s Professor of Public Scholarship and Engagement — focused on growing partnerships, both in number and depth.

**Idaho has one of the fastest-growing economies in the nation** and higher education institutions in Idaho contribute **\$4.5 billion to the state’s economy**. Industry has called on Boise State to play a key role in American competitiveness in energy and semiconductors. The university has invested in these strategic and critical growth areas. Boise State is the only university in Idaho to become a member of the national Council on Competitiveness.

The Institute for Advancing American Values represents **Boise State’s commitment to civil discourse, free speech and Idaho voices**. Through a series of events held on campus and around the state, a wide range of perspectives have been presented to numerous audiences, who agree, simply, to listen.

# IDAHO



From the jagged peaks at its center to the rolling hills and lakes of the panhandle and the rich farmland of the Snake River Plain, Idaho is a land of striking contrasts. Mt. Borah rises to a dramatic 12,662 feet, while the Port of Lewiston — at just 738 feet above sea level — is the most inland seaport on the West Coast. Idaho is home to sand dunes, lava fields and the aromatic sagebrush steppe. Eastern Idaho is a gateway to Yellowstone Teton Territory, which includes some of the most stunning landscapes in the world.

Each year, more than 20 million visitors come to experience Idaho's unspoiled beauty, including 3,500 miles of rivers — more than any other state in the Lower 48. Nearly two-thirds of Idaho is public land, offering vast spaces to explore and experience quiet solitude — even in one of the fastest-growing states in the union.

Key industries include agriculture, food processing, technology, mining, and tourism. As of 2024, the state had a population of just over 2 million people. [VisitIdaho.org](https://www.visitidaho.org)

## Leadership

Appointed by the Idaho State Board of Education in April 2025, Dr. Jeremiah Shinn serves as interim president of Boise State University. He also holds the role of vice president for student affairs and enrollment management, a position he assumed in early 2023.

Dr. Shinn previously spent nearly a decade at Boise State (2010–2019) in various student affairs leadership roles before serving three and a half years as vice president for student affairs at Louisiana State University. Earlier in his career, he held positions at Indiana University and Eastern Michigan University.

A graduate of Arkansas Tech University (B.S.), the University of Michigan (A.M.), and Eastern Michigan University (Ph.D.), Dr. Shinn has taught at both the undergraduate and graduate levels. He is dedicated to ensuring students have the services and programs needed to succeed, supporting faculty, advancing the state of Idaho, and fostering research excellence at Boise State.
