## The Opportunity

MorseLife Health System (MorseLife), a nationally recognized leader in senior care headquartered in West Palm Beach, Florida, seeks an accomplished and visionary fundraising executive to serve as its Senior Vice President, Development. The Senior Vice President, Development will serve as a visible ambassador and trusted partner advancing MorseLife's bold vision for the future of aging services.

MorseLife is a mission-driven, not-for-profit organization ranked 50th on the 2025 Ziegler LeadingAge 200 Report. They provide a full continuum of senior care services, including Independent Living, Assisted Living, Memory Care, Long-Term Care, Home Health, Hospice, PACE (Program of All-Inclusive Care for the Elderly), and innovative programs such as cannabis-based therapies and Parkinson's treatment. Serving more than 3,600 seniors daily across three communities in Palm Beach County, MorseLife is recognized for excellence, compassion, and innovation in aging services. The organization has earned a five-star ranking from the Agency for Health Care Administration (AHCA), the Gold Seal Award from the Governor's Panel on Excellence in Long-Term Care, multiple recognitions from *U.S. News & World Report* as one of the nation's best nursing homes, and prestigious Joint Commission Accreditation.

Reporting to the President & CEO of MorseLife Health System, the Senior Vice President will have the opportunity to strategically position MorseLife Foundation for future success. This is the primary fundraising and events planning leadership role serving the organization and its charitable arm, the MorseLife Foundation.

The MorseLife Foundation sustains and strengthens MorseLife's mission by raising funds that provide approximately \$10 million annually to support free or subsidized services to low-income seniors. These services include nutritious meals, health care, transportation, companionship, and innovative programs that enhance quality of life. The Foundation also supports initiatives such as the Meals-on-Wheels Mitzvah Program and Palm Beach PACE, ensuring seniors receive care with dignity and respect.

The Senior Vice President provides strategic direction and operational leadership for all philanthropic initiatives, including major gifts, planned giving, annual campaigns, grants, events, and special projects. This leader will develop a comprehensive annual fundraising plan, set goals through the budgeting process for new gifts and pledges, cash collections, and expenses, and create a strategic plan for the Foundation. They will monitor progress on revenue and other success measures and manage expenses within budgeted expectations.

The Senior Vice President will ensure continuous mission support and lead the stewardship and distribution of charitable gifts across the organization. Acting as the senior major gifts and planned giving officer, the new leader will manage a portfolio of prospects and donors, cultivate relationships, and ensure long-term engagement through regular communication and impact reporting. They will design and implement strategies to grow and retain donors while identifying new opportunities. As a key member of the leadership team, the Senior Vice President will contribute to strategic decisions on program management and development, and lead the Foundation staff, including hiring, training, and performance management.

MorseLife's next Senior Vice President, Development will be a mission-driven, strategic leader with a proven track record in fundraising and organizational transformation. The ideal candidate will possess deep knowledge of philanthropy and experience building and scaling fundraising programs, including expertise in major gifts, planned giving, annual campaigns, and donor stewardship. They will demonstrate strong leadership and colleague-collaboration skills, inspire generosity, and strengthen community engagement. Aligning the organization's philanthropic objectives with broader organizational priorities will be a key objective for the new Senior Vice President.

## Organization Overview

MorseLife Health System has been transforming senior living and care for more than 40 years, founded in 1983 as the Jewish Home for the Aged in Palm Beach County. Established with a mission rooted in dignity, compassion, and the spirit of Jewish tradition, MorseLife has grown into a nationally recognized, not-for-profit leader in senior healthcare and housing. Today, MorseLife touches the lives of thousands of older adults daily through an integrated continuum of services—from all-inclusive independent and assisted living to short-term rehabilitation, long-term care, memory care, home health, PACE, hospice, and palliative care. Guided by its commitment to innovation and inclusivity, MorseLife creates vibrant communities where seniors of all backgrounds can thrive, living life fully and meaningfully at every stage.

### Mission

Dedicated to providing the most enlightened and compassionate continuum of care to seniors on our campus and throughout Palm Beach County in the spirit of Jewish traditions.

### MorseLife Foundation

The MorseLife Foundation powers the charitable mission of the MorseLife Health System, enabling vital services that enhance the lives of seniors in its care. Each year, MorseLife provides approximately \$10 million in free or subsidized life and health care services to low-income elderly in the community—a goal made possible through the Foundation’s fundraising efforts.

Through generous support, the MorseLife Foundation funds innovative programs that touch the lives of 3,600 Palm Beach County seniors every day. These programs range from essential services—such as nutritious meals, health care, transportation, and companionship—to creative initiatives that incorporate the arts and technology, constantly exploring new ways to enrich senior living.

With approximately \$10 million in free or subsidized services annually, including the community-based Meals-On-Wheels Mitzvah Program and PACE (Program of All-Inclusive Care for the Elderly), MorseLife leads the way in treating seniors with excellence, dignity, and compassion.

### Program Areas Supported by the Foundation

**NOW for Holocaust Survivors** – provides essential support to impoverished Holocaust Survivors and their families in Palm Beach County. It addresses urgent needs such as food insecurity, isolation, and lack of access to care through services including:

- **Home Health Care:** Skilled nursing, housekeeping, errands, socialization, and safety repairs.
- **Financial Assistance:** Emergency rent, utilities, and other vital needs.
- **Nutrition:** Meals-on-Wheels and meal preparation.
- **Care Management:** Medical assessments, counseling, medication management, and personal care.
- **Enrichment & Support:** Music and art therapy, virtual reality experiences, and transportation.

**Hospice & Palliative Care** is the only hospice in Palm Beach County offered by an organization with a history of specializing in serving the Jewish community. It is also the only organization designated by the Florida legislature as a Teaching Nursing Home and a Teaching Hospice.

**Meals-On-Wheels** – with the help of their committed, passionate volunteers, MorseLife Meals-On-Wheels provides a necessary solution, serving 50,000 meals to approximately 2,500 low-income, homebound seniors in Palm Beach County each year, without regard to a client’s ability to pay.

**Life Enhancement** – includes various enriching approaches, from augmented reality (AR), music and memory to innovative art and cooking programs designed to enhance ailing seniors' minds and bodies.

**Holocaust Learning Experience** – are fully developed, classroom-ready lessons, aligned to the highest standards, and deployed through MorseLife's secured learning platform. It now operates within a growing network of districts educating over 3 million students—proving its scalability and national relevance. For teachers, it's a gift. For the country, it's a path toward unity.

**Nursing Education Scholarships** – These scholarships fund training, exam fees, books, supplies, and compensate for the 120 work hours nursing students miss while in school. Additionally, they help ensure that MorseLife can recruit and train sufficient numbers of qualified nursing staff to care for its seniors. Baby Boomers are aging, and people are living longer. The number of Americans aged 65 and older is projected to double—from 46 million to 98 million—over the next 40 years.

## Communities and Services

### The Levin Palace

At MorseLife, the philosophy known as “Younging™” is at the heart of the Levin Palace. This lifestyle is designed for independent, active individuals aged 65 and older. The elegant senior living community makes every day feel like royalty—worry-free and delightful.

### Tradition

Tradition is MorseLife's luxury independent and assisted living residence, offering flexibility to create a lifestyle that suits each resident best. Residents can choose between à la carte Independent Living and tiered Assisted Living, with varying levels of care, all designed to support independence while adapting seamlessly as needs evolve.

What sets Tradition apart is its commitment to financial clarity. Whether residents choose Independent or Assisted Living, annual costs remain consistent and are adjusted only by standard cost-of-living increases typical of not-for-profit communities. This model delivers both peace of mind and financial predictability.

**Resnick Assisted Living and Memory Care** reflect MorseLife's long-standing mission to honor senior living with dignity, compassion, and respect. Assisted Living or Memory Care at Resnick provides home-like settings that enhance quality of life by offering residents socialization, services, personal assistance, and specialized care - all-inclusive and reasonably priced.

- Resnick Assisted Living was created especially for seniors who need and want affordable Assisted Living. Everything—activities, amenities, meals, and assistance with daily routines—is right at their doorstep, designed for older adults on a budget.
- Resnick Memory Care in West Palm Beach, Florida, provides affordable programming, care, and support centered on life enrichment for individuals with progressive memory disease who may be on a budget. Highly trained caregivers provide a secure environment fostering comfort, dignity, and inspiration, ensuring residents are encouraged and engaged in daily life.

### Services

**Assisted Living** – MorseLife offers an extended range of Assisted Living options designed to meet diverse income levels and health care needs for older adults.

Regardless of the model selected, residents receive the highest quality care with a focus on compassion, dignity, and respect. From Tradition, MorseLife's luxury assisted living residence, to Resnick, its affordable assisted living option, and Memory Care Assisted Living, each community provides exceptional care, meaningful social interaction, and programs that enrich quality of life.

**Cannabis-Based Therapies** – MorseLife is committed to reducing or replacing opioids and other pharmaceuticals that can lead to undesirable and potentially dangerous side effects. It is the only senior care provider in Florida authorized by the state to offer cannabis-based therapies across multiple care settings under a newly organized pilot program.

Cannabis-based therapies include THC and CBD-infused products, such as those available through Florida's medical marijuana program, and are recognized for their promising health benefits. Under the supervision of a licensed medical marijuana physician, cannabinoids have shown positive results in treating chronic pain, supporting neuroplasticity, improving mood and emotional health, alleviating insomnia, stimulating appetite, reducing nausea, and easing chemotherapy-related discomforts.

MorseLife has also achieved commendable outcomes in managing clients with all types of dementia, reinforcing its leadership in innovative, compassionate care.

**Care Management** – MorseLife Care Management provides guidance and referrals to families navigating the challenges of helping older loved ones remain secure and independent at home. The team works closely with seniors and their families, including those living out of town, to source and coordinate care, act as a liaison to oversee services and report concerns, and assist with long-term planning.

**Home Health Care** – MorseLife offers preferred home health care services, including **Private Home Health Care** and **Skilled Home Health Care**, to support recovery from injury or illness, manage chronic conditions, and assist with daily tasks at home.

- Private Home Health Care services are designed for seniors who need help with daily routines but prefer to remain in their homes. Clients receive compassionate, dignified, and respectful care in the comfort and familiarity of home, giving families peace of mind.
- Skilled Home Health Care may be necessary only as long as the patient is recovering from an illness or injury, or it may be desirable longer-term for seniors who need care regularly. Individuals prefer to remain at home while receiving their treatment options versus living in a skilled nursing facility or other community. MorseLife has responded to this by offering top-tier Skilled Home Health Care that enables those individuals to benefit from highly proficient home health care services while retaining as much independence as possible.

**Hospice Care** – The mission of Palm Beach Hospice and Palliative Care is to provide outstanding, dignified care for terminally ill patients anywhere in Palm Beach County by minimizing their suffering, enhancing their comfort, and supporting families while upholding Hospice's life-celebrating values. Known for its exceptional and compassionate patient care, MorseLife is also a teaching facility. Integrating an academic approach into its Hospice and Palliative Care program with community lectures, symposia, and education about Hospice helps families and patients better understand the Palm Beach Hospice and Palliative Care philosophy and program.

**Independent Living** – Usually reserved for those aged 65 and over, an Independent Living community caters to seniors with an array of amenities such as fitness centers, movie theaters, art studios, and more. It removes chores and home maintenance for seniors by providing housekeeping, groundskeeping, and other services within one monthly fee.

Independent Living communities also offer programming, events, and activities like concerts, lectures, cooking demonstrations, and film screenings, to name a few. This encourages socialization and promotes engagement for

holistic well-being. Not all senior living communities offer other levels of care if daily needs change, but at MorseLife, the goal is to ensure added peace of mind by providing a full continuum of care right on campus.

**Long-Term Care** – Long-Term Care may be advisable for older adults with a serious illness or chronic condition. Skilled nurses on-site day and night are trained to recognize unusual changes in a resident's condition. If such changes occur, or when a loved one's health is at risk, medical care is ordered immediately. Long-term care may also be suitable for seniors who have difficulty moving or are unable to get out of bed. MorseLife has the equipment to facilitate movement and minimize discomfort in an atmosphere of respect and kindness.

The staff also monitors for declines or changes in a resident's health that may indicate the need for additional support in the future. This help could be in the form of Hospice or Memory Care. They have earned the following accolades:

- **Five-Star Ranking** – Agency for Health Care Administration (AHCA)
- **Gold Seal Award** – Governor's Panel on Excellence in Long-Term Care (earned by fewer than 2% of providers in Florida)
- **Best Nursing Homes** – Recognized multiple times by *U.S. News & World Report*

**Memory Care** – People experiencing cognitive changes can continue to feel joy, fulfillment, and growth with memory care. This level of senior living is designed around residents' daily needs. Staff receive training to understand cognitive change in seniors and uplift and support those experiencing it.

Those with Alzheimer's, Parkinson's, or other forms of dementia deserve to live meaningful lives and to feel safe and at ease, and loved ones deserve to know that trusted care is always available. Memory Care offers those with cognitive challenges security and support in a familiar environment, designed to promote independence.

With easy-to-navigate layouts, compassionate care, and personalized programming, Memory Care enhances and empowers quality of life while ensuring residents' safety.

**PACE (Program of All-Inclusive Care for the Elderly)** – Palm Beach PACE is a model of health care centered around the belief that the well-being of seniors with chronic care needs, and their families, are better served in their communities whenever possible.

The mission of Palm Beach PACE is to prevent unnecessary nursing home admissions, something older adults feel strongly about. The comfort of home, family, and the community is essential to their sense of well-being, stability, and security. MorseLife serves PACE participants by meeting their healthcare needs at home and at its PACE centers throughout Palm Beach County.

MorseLife is the exclusive PACE provider in Palm Beach County. PACE offers seniors comprehensive community-based healthcare solutions that honor their independence and individuality by meeting their medical and social wellness needs with compassion, dignity, and respect.

One of the fastest-growing PACE providers in the country, MorseLife currently has three Palm Beach PACE locations. The primary site is on the MorseLife Campus in West Palm Beach. PACE Delray serves South Palm Beach County. The newest PACE in Greenacres serves central and western communities.

**Palliative Care** – MorseLife Palliative Care in West Palm Beach, Florida, helps those with chronic illness and their families enjoy the best quality of life by alleviating the discomfort and stress of serious illness, from diagnosis through treatment and beyond. Consistently delivering the highest standard of care with dignity and compassion is MorseLife's guiding principle. It is just one more reason why MorseLife is More Life.

The mission of MorseLife Palliative Care is to provide relief from the symptoms and stress of chronic disease while also focusing on the physical, emotional, psychological, and social needs of patients and their families. At any stage of illness, Palliative Care helps individuals carry on with daily life, better understand their condition and medical care, receive support through medical treatments, and live their best life.

**Parkinson's Therapy** – The Parkinson's therapy program at MorseLife was initially created to meet the distinctive needs of MorseLife's long-term care residents who suffered from Parkinson's Disease or other movement-related disorders. Since its launch in 2020, the program has positively impacted the lives of many MorseLife patients and their loved ones.

- **Lee Silverman Voice Treatment™ (LSVT)** – Used worldwide, this pioneering, holistic program includes highly individualized Parkinson's treatment plans using certified therapy techniques to promote improved movement by addressing diminished speech, cognitive decline, and other challenges associated with Parkinson's and neurological disorders.

**Short-Term Rehab** – MorseLife's luxurious Sondra and David S. Mack Pavilion for Short-Term Rehabilitation in West Palm Beach, Florida, is rapidly changing the culture of short-term rehabilitation, and there is a good reason why. While the goal is to help patients recover quickly after illness or injury, MorseLife believes there is more to short-term rehab than therapy. It is also vital that patients have both privacy and the opportunity to socialize with others in a relaxed, comfortable setting.

MorseLife's innovative environmental design, private suites, leading-edge technologies, and distinguished interdisciplinary team focus not only on treating the specific illness or injury that brought patients to short-term rehab, but also on their physical, psychological, and social needs. MorseLife created a medical model in a social setting to ensure rapid recovery, focused on mind, body, and spirit. The goal is to encourage holistic recovery and a rapid return to family and home.

## Position Summary

The Senior Vice President, Development will lead the development and implementation of a comprehensive fundraising strategy to maximize philanthropic support and ensure effective stewardship of the Foundation's assets. This role will align all initiatives with organizational priorities and oversee MorseLife Foundation's programs and development efforts. The Senior Vice President will manage relationships with both internal colleagues and external stakeholders to advance the Foundation's mission and implement strategic marketing plans to enhance visibility and engagement.

This position requires the new leader to leverage leadership strengths to drive mission-focused initiatives, cultivate high-value donor relationships, and create lasting community impact. It provides visibility with executive leadership, influence over resource allocation, and the ability to shape transformative programs aligned with organizational goals.

MorseLife fosters an engaging, results-oriented, fast-paced, and mission-driven culture that values excellence, accountability, and measurable outcomes and is deeply grounded in purpose, service, and community impact.

## Responsibilities

The successful Senior Vice President, Development candidate will:

- Lead the development of a comprehensive, annual fundraising plan that responds to the needs of the MorseLife Foundation and supported organizations.
- Determine annual goals for new gifts and pledges, and cash collections, through the budget process. Develop a three to five-year strategic plan for MorseLife Foundation. Monitor and communicate (President & CEO, Board leadership, and direct reports) progress on revenue and other success measures, while managing MorseLife Foundation expenses within budgeted expectations.

Direct and oversee the receipt of charitable gifts, their financial stewardship, and their ultimate distribution to the MorseLife Health System and related entities, to ensure continuous support of the MorseLife Foundation and the supported organizations' mission.

Provide direction for the implementation of the organization's annual and special events.

- Act as the senior major gifts and planned giving officer, actively managing a portfolio of prospects and donors, meeting regularly to develop and build relationships.
- Ensure a long-term relationship is forged with donors by maintaining contacts and educating donors on outcomes and results of MorseLife Foundation's efforts.
- Design and implement growth and retention strategies with existing donors and opportunities to develop new donor relationships.

- Serve as a key leadership team member and active participant in making strategic decisions regarding MorseLife Foundation revenue development strategy.
- Manage and nurture the development of foundation staff, including hiring, training, and evaluating performance.

## Goals and Objectives

The Senior Vice President, Development, must demonstrate meaningful progress within the first 18 to 24 months of their tenure. Key areas are listed below in no particular order of priority.

- Implement and refine a philanthropic strategic plan that supports organizational recovery, long-term sustainability, and mission alignment.
- Gain clarity on the foundation's portfolio within the first 30 days, finalizing strategies for restricted and unrestricted funds.
- Position philanthropy as a catalyst for growth and innovation, expanding beyond its current baseline.
- Expand planned giving and estate gifts initiatives to enhance long-term philanthropic support.
- Strengthen foundation and corporate giving through proactive identification and stewardship of key prospects and relationships; Develop effective grant proposals.
- Increase donor engagement through strategic involvement and relationship management.
- Provide strategic direction for Morse Life's annual and special events.

### Foundation Operations, Performance, and Metrics

- Establish clear goals, metrics, and systems to track fundraising performance, donor engagement, and stewardship outcomes.
- Leverage operations by strengthening follow-up, leveraging the CRM to professionalize operations, support donor cultivation, strengthen follow-up and create consistent processes.
- Achieve established fundraising targets within the annual giving society and secure major gifts to advance organizational goals.
- Support benevolence, chaplaincy, volunteer programs, and community renewal efforts.
- Supply transparent stewardship reports to donors, the executive team, and the Board.
- Transition the foundation from maintenance mode to one of growth.

- Serve as a credible, mission-driven partner to Board members, reinforcing philanthropy's role as an essential driver of sustainability and transformation.

## The Community

### West Palm Beach, Florida



Palm Beach County, located in South Florida, blends urban sophistication with coastal living. The county is well-connected through major highways, Tri-Rail, Brightline, and Palm Beach International Airport. 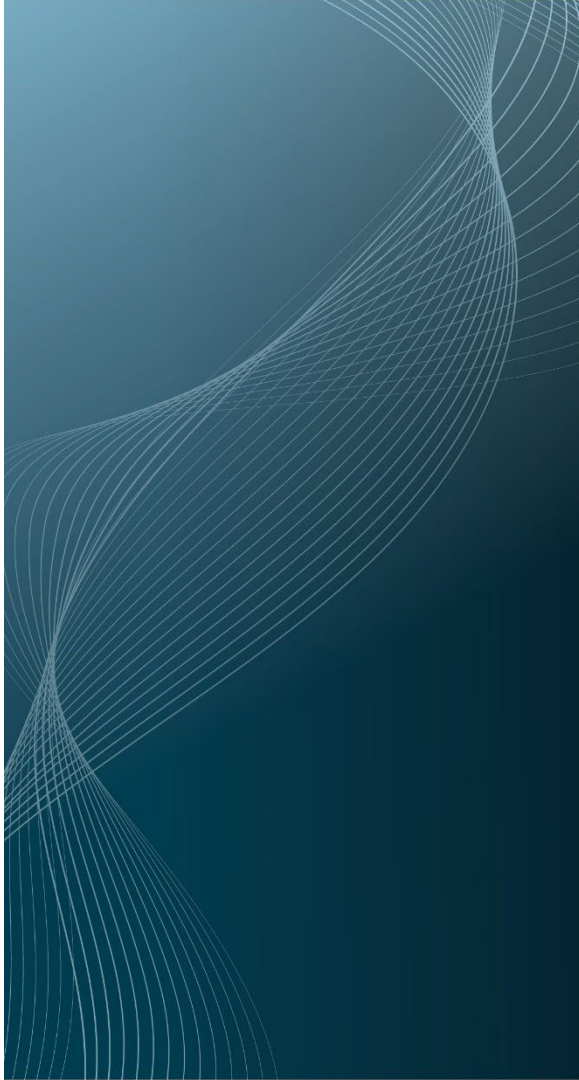
